Superintendent details Stage 1 reopening plans for Plaq. Schools

Last week the Plaquemines Parish School Board unanimously approved Superintendent Denis Rousselle's plan for reopening parish schools come Aug. 6.

The initial plan is far from final as the state sees spikes in coronavirus cases amidst

Phase 2 reopening, but PPSB's plan, which Rousselle is calling Stage 1, would see the majority of students return to in-person schooling.

Rousselle said during the June 29 special meeting that every school except Belle Chasse Middle School and Belle Chasse High School has enough space to adhere to Phase 2's 50 percent capacity

and six-foot distancing rules. That means some students may be attending class in the gym, but they will be physically present at school.

At Belle Chasse Middle, only fifth and sixth graders will return to the school. Seventh and eighth graders, along with all Belle Chasse High School students, will participate in distance learning for the first

nine weeks of the school year. At the same time, Belle Chasse High School will become a resource center for students and parents participating in online classes.

"The resource center will help people struggling with distance learning," Rousselle said after the meeting. "There

Parish Republican, Democratic Committee seats up for grabs on July 11 ballot

All the drama has been sucked out of the presidential primary elections this go round, but there are multiple local elections on the July 11 ballot in Plaquemines Parish.

In every ward and precinct, registered Republicans will vote to fill five At-Large seats in a six-person race for the Republican Parish Executive Committee. Candidates include David R. Clark, Mitchell R. Cota, Lucien Cusimano, Mary Fay Legnon, Mike Mariana and Randy Oustalet.

And in every ward except Ward 1, registered Democrats will vote in two Democratic Senatorial Campaign Committee 105th Representative District races. For the Office A seat, Vanessa Turner Billiot is facing Lisa Ray Diggs. For the Office B seat, Darren Lombard is facing Burghart Turner.

All ballots still feature the full cast of characters for Democratic Presidential Nominee even though every candidate other than Joe Biden packed up their tents months ago. There are also four candidates not named Donald Trump throwing Hail Marys to be the Republican Presidential Nominee.



Second Term

Plaquemines Sheriff Jerry Turlich and Clerk of Court Kim Turlich-Vaughan were both sworn in to begin their second terms at separate ceremonies late last month. Sheriff Turlich was sworn in by Fourth Circuit Judge Joy Cossich Lobrano June 28 at Woodland Plantation. Clerk of Court Turlich-Vaughan was sworn in by 25th Judicial District Court Judge Michael Clement at the Pointe a la Hache Courthouse June 30. Both officials' new terms began July 1.

New Plaquemines civil rights group hosting Parishwide Rally Saturday

A new civil rights organization born out of the historic June 12 "I Can't Breathe" Protest in Belle Chasse will hold its first public event this Saturday.

The Minorities for Equality and Justice Association (MEJA) will host a Parishwide Rally July 11 at Ironton Park at 1 p.m. to continue the discussion

around racism in Plaquemines Parish that began with the June 12 event. Just as the "I Can't Breathe" Protest ended with a series of testimonials from black citizens sharing their experiences with institutional racism in Plaquemines, a flyer advertising the Rally on social media asks participants to "bring your

concerns on racial injustices."

The Rally will also expand MEJA's scope beyond public comments into political initiatives like voter registration and recreational elements including cook-offs and a classic car show. More information on the group can be found online at themeja.org.

Council to debate asking Plaquemines voters for \$9 million in new taxes

Plaquemines voters could have five new millages waiting for them on the Dec. 5 ballot depending on how the Parish Council votes July 9 in Belle Chasse.

Six new 10-year millages totaling 10.75 mills were introduced at the council's June 25 meeting in Pointe a la Hache, but two of those proposals are competing plans for funding recreation. Assuming the council passes one of the two rec millages and all four of the others, the Dec. 5 ballot will include either 9.25 mills (\$9.1 million) or 9.75 mills (\$9.6 million) in proposed new taxes. From there, whichever taxes pass in December won't be collected until 2021 and won't land in parish accounts until 2022.

Parish President Kirk Lepine said any millages that fail will serve as a de facto referendum on which services citizens are willing to see slashed.

"I would hate to cut recreation or mosquito control, but if we can't afford something, we're definitely going to have to adjust," said Lepine.

District 9 council member Mark "Hobbo" Cognevich, who put forth a 2-mill proposal to fund EMS and ambulances, put

Coronavirus scuttles Miss. River Bank merger

For the second summer in a row, an outside bid to acquire Mississippi River Bank has failed.

MRB President and CEO Mike Bush confirmed last week that American Bank & Trust's anticipated merger with the Plaquemines Parish bank failed due to economic conditions in the midst of the coronavirus pandemic. The announcement comes one year after River Road Financial Corporation failed to raise enough capital by a June 2019 deadline in its bid to buy MRB.

"What happened in this one is the collapse of

will be teachers and counselors and tech people there in person to advise students in small groups. The accountability will definitely be there and we're much better prepared and have more resources at this time than we did at the end of last year."

Parents who aren't comfortable sending their students back to brick-and-mortar schools will also have the option to enroll their student in distance learning. The district has enough Chromebooks to ensure that every student in the district has a computer at home, and Rousselle said wireless internet will be available at multiple school locations for those without reliable internet at home.

He added that AT&T is still working with the school district to identify and improve areas with poor service.

Rousselle said at the PPSB meeting that standards will be stricter for students participating in distance learning this year, with lessons and tests becoming mandatory where last year they were voluntary.

Students in the third grade and above who return to school will be asked to wear a mask whenever possible. Schools will provide students with masks.

Water fountains will also be closed, so students are encouraged to bring their own drinking water.

Busing will be tricky as the district adheres to the state's 50 percent capacity rule, so Rousselle is asking that parents drive their children to and from school whenever possible. Students will also have their temperatures taken each morning, so car riders with elevated temperatures will be able to leave immediately with their parents while bus riders with elevated temperatures will be quarantined until they can be picked up.

Due to both busing, which may require that routes be run multiple times in addition to disinfecting after each trip, and teachers devoting part of their day to online lessons, schedules may be somewhat unorthodox. Those schedules are also subject to change if the state moves into a different phase or if Plaquemines Schools move into Stage 2.

Parents with questions about PPSB's Stage 1 reopening plan may attend the board's next meeting July 13 at 6 p.m. at Belle Chasse Elementary School.

Historical Association postpones July - September meetings

The Plaquemines Parish Historical Association announced they would continue their meeting postponement another three months pending the corona virus crisis.

According to Mark Cognevich, association president: "This is a much worse medical crisis than we re-

alized back in March when we decided to postpone our April-June meetings. Many of our members are over 50 and may be particularly susceptible to the virus, so we do not want to take any chances by scheduling meetings too soon. As a result we are again postponing our monthly meetings through

September. Our board will meet in September to evaluate whether we think it safe to schedule the Tuesday, Oct. 6 meeting. Our status is reported on Facebook (Plaquemines Parish Historical Association), via the Plaquemines Gazette and through emails to our members."

it more bluntly. "If they want the services they're going to have to vote for them," said Cognevich. "Oil royalties ain't like they used to be."

District 5 council member Benny Rousselle said he wants to hear more from Lepine's administration about how it plans to streamline government in order to cut costs. Then after the council passes whichever proposals can get five votes, Rousselle said it's the parish president's job to assure citizens that the new taxes are worth their money.

"He needs to justify the case for these millages. He needs to sell this program and how he's going to handle it," said Rousselle.

Lepine acknowledged that the estimated \$7 million shortfall the parish is facing due to low oil prices and the coronavirus is going to result in some cuts in the 2021 budget. The proposed \$9 million will buoy services in 2022 and beyond.

Proposed millages

While administration played an advisory role in describing the parish's needs, Lepine said he left it up to

council members to propose the millages themselves. District 4 council member Stuart Guey, District 6 council member Trudy Newberry, District 9 council member Richie Blink and Cognevich then worked with Lead Parish Attorney Rennie Buras to draft the proposals.

Guey put forth 5 mills for levees and flood protection, which will bring in an estimated \$4.9 million per year.

Blink put forth 1 mill for mosquito control machinery or equipment, which will bring in an estimated \$985,000 per year.

Cognevich put forth 2 mills for EMS "directly or by contract" to fund facilities, vehicles and equipment. That would bring in an estimated \$1.97 million per year.

Newberry put forth three proposals, including the competing recreation millages. She proposed .25 mills (approximately \$246,000 per year) for elderly support programs. She also proposed 1 mill (\$985,000 per year) and 1.5 mills (\$1.47 million per year) for recreation, with the larger proposal encompassing the Port Sulphur and Buras YMCAs as well as the Davant Summer Recreation program and the 4-H program.

Newberry said the 1.5 mill

option would even create a surplus of around \$200,000 per year in the Rec Department.

District 2 council member Beau Black has publicly objected to the annual \$50,000 grant Plaquemines Parish Government has handed over to the Pointe a la Hache Fire Department to operate the Davant Summer Rec program. The grant is primarily intended to fund the swimming pool at the Percy Griffin Community Center during the summer, but questions over how the remainder of the grant has been spent led the parish to audit the fire department in 2019.

Black also called for tighter controls on spending instead of new taxes.

"I cannot support any attempt to increase residential property taxes while this government continues to deficit spend and not correct the issues within the departments that have historical annual budget shortfalls," read a text from Black. "However, I do consider supporting the 1 mill proposal for recreation only if the funds will be used for parish-wide recreation and are set up in a revenue fund where recreation essentially will be able to operate independently from the general fund. I would also consider supporting and increasing the proposal for

the stock market and COVID-19. Regulators thought it was in the best interest for the banks not to get married at this time," said Bush. "There were some additional products we would have been able to offer with the merger. But we're still a community bank with a primary focus on

lending and small businesses and management will look into providing additional services in the future."

Under the terms of both deals, MRB negotiated to retain all 22 of its employees and keep both the Belle Chasse and Port Sulphur branches open.

Bush said the possibility exists that American or another bank may propose a merger with MRB

after economic conditions stabilize. However, in the case of both American's and River Road's proposals, MRB was performing well and was not looking to merge.

"The bank is doing fine and we won't be looking again. But that doesn't mean someone won't come along and possibly want to acquire the bank in the future," said Bush.

Council on Aging from .25 to 1 mill if all community grant programs, such as the CARE Center, LSU Ag and the YMCAs in Port Sulphur and Buras, were included in one package."

The Plaquemines Association of Business & Industry took a similar position, stating in a letter to Lepine and

council members that "while it may be an option for us to support tax increases, spending has to be reduced to bare minimums and fees for services provided by the parish should be increased so departments operate closer to break-even."

PPG department deficits

not addressed by the proposed millages include the Ferry Department (\$3.7 million), buildings (\$3 million) and road maintenance (\$1.5 million).

The council's Aug. 27 meeting is the latest it can vote to place any of the proposed millages on the Dec. 5 ballot.

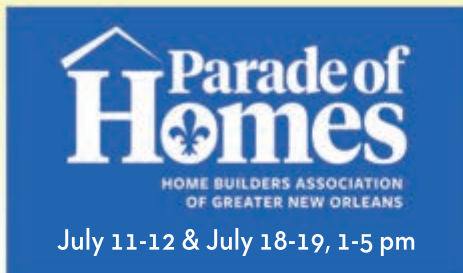

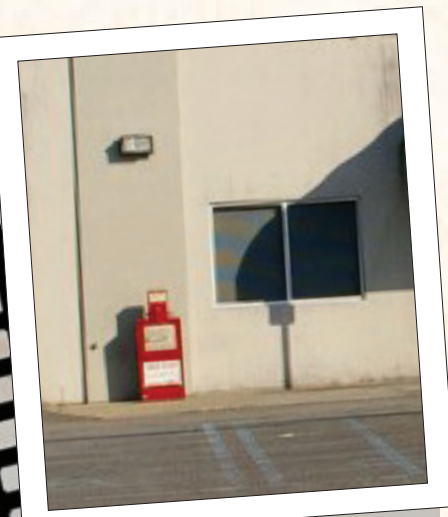



PUBLIC SCOPING MEETINGS

The Coastal Protection and Restoration Authority of Louisiana (CPRA) has applied to the U.S. Army Corps of Engineers, New Orleans District (CEMVN) for Department of the Army permits and permissions to construct, maintain, and operate the proposed Mid-Breton Sediment Diversion (Proposed Project). To inform these permit decisions, CEMVN is preparing an Environmental Impact Statement (EIS) in compliance with the National Environmental Policy Act (NEPA). In addition to informing CEMVN's permit and permission decisions, the EIS may inform decisions by other agencies regarding any additional regulatory or permit processes required for the Proposed Project.

As part of the preparation of the EIS, NEPA requires an early and open public process for determining the scope of issues, resources, impacts, and alternatives to be addressed by the EIS, commonly referred to as "scoping". CEMVN invites the public and all interested parties to provide comments on the Proposed Project, alternatives that should be considered, and potential environmental issues that need to be evaluated in the development of the EIS during the scoping period. The scoping period to provide comments for the EIS will extend 45 days from the posting of the Notice of Intent (NOI) in the Federal Register which is expected by the end of June.

Due to COVID-19 restrictions and to ensure public safety, CEMVN will conduct scoping meetings virtually. Commissioner Rousselle asked if she did not interpret Resolution 16-138 to require the Port to submit RFPs or RFQs to the Board prior them going out to the public and Chambrel Riley said no because there is no trigger on when they are to be submitted to the Board or ask for permission to seek the proposals or quotes. Commissioner Rousselle explained that the intention of resolution was to inform the Board as to when the requests are going out for said services. He further stated that the resolution needs to be amended so the intent is clear. Commissioner Rousselle asked if during the proposal process does the Port entertain people who you are seeking proposals from and was told no by Chambrel Riley. Commissioner Rousselle said that according to expense reports, in January Sandy Sanders and Paul Matthews took individuals to lunch and then ended up giving them a contract last week. Minutes of a meeting of the Plaquemines Parish Council, held in the Pointe-a-la-Hache Council Chambers, 18055 Highway 15, Pointe-a-la-Hache, Louisiana on Thursday, June 25, 2020, at 6:12 p.m., pursuant to notice to all members with a quorum present as follows:

President Lepine, Directors Todd Eppley, Crystal Taylor and Scott Rousselle were present representing the Administration.

Agenda item 9n, "An Ordinance declaring all Parish-owned non-movable property not currently being used as surplus property; authorizing and directing the Parish President or his designee to sell all the non-movable property which is declared surplus; and otherwise to provide with respect thereto" was withdrawn.

There being no items for "Executive Session" and no items under "Proclamations", Council Member LaFrance moved to Agenda Item 4, "Status Report by the Parish President" wherein President Lepine said he had nothing to report. Council Member Rousselle inquired into the email he sent to President Lepine regarding Ranatza Trailer Park wherein the President responded that he would send the information to Mrs. Newberry since it was in her district. Council Member Rousselle said he did not receive any information. President Lepine replied that there was no update. Council Member Rousselle asked the Council Secretary to add this matter to the agenda under "Status Report by the Parish President" for the next council meeting.

Council Member LaFrance moved to Item 4b, "Update by Charter Directors". Without objection, so ordered. The following was discussed:

- Council Member Newberry asked the Director of Administration, Crystal Taylor, information on the food distribution events to be sent to the Council Members in order for them to be able to participate. She also asked if there was any information about an upcoming distribution in Belle Chasse. Director Taylor explained that there are two different food distributions. One is for the commodities which is set up by Community Action and then the other is set by Second Harvest. She will send information on dates and locations to the Council. Mrs. Taylor said she has not spoken to Donald Sino regarding the Belle Chasse distribution. She did explain that the food provided for all of the distributions is provided by

Second Harvest; however, you need to register for the commodities distribution by Community Action;

- Council Member Cognevich said he spoke to the lady with the Census and she said that Crystal Taylor has been a huge help. Director Taylor thanked Council Member Cognevich and said that Keith Espadron has been a great help also. She further said that the numbers have gone up but, we can do better and they are planning more activities to increase the numbers;
- Council Member Barthelemy explained that Crystal Taylor has tried to get information on locations and dates of food distributions; however, the individuals setting up the distributions have not gotten in touch with her. Director Taylor said she did hear from the head of Second Harvest and they will let her know ahead of time and Scott Rousselle will have the trash picked up;
- Council Member LaFrance asked the Council Secretary to place an item on the agenda for the Administration to have an update on Parish equipment, dozers, excavators, fire trucks, ambulances, tractors, garbage trucks and vehicles in order to try to update some of the equipment.
- Council Member Barthelemy asked for an update from the Administration on the Waterline on the Northern end on the East Bank and an update/status report by the Administration on the Parish-wide Summer Recreation program to be placed on the next agenda; and
- Council Member Rousselle said he understands that President Lepine does not want to speak on items not on the agenda because of the purpose of allowing people to be notified but, since most of the time there is no update, that is what drives us to ask about certain issues. He asked President Lepine if he will provide topics for his status report for the agenda. The President replied; however, it was inaudible because he did not go to the microphone. Attorney Rennie Buras said if the Council has specific questions about specific issues, they can contact him any day of the week or have the Council Secretary put it on the agenda so he can have the information and be ready to speak on the matter. Rennie Buras then left the podium and made more comments; however, it was inaudible because he did not go to the microphone. Council Member Rousselle made a statement that if anyone wants to speak, they need to do so into a microphone. Mr. Buras said that they are not afraid to answer any question they just need ample time to find out the information needed to answer. He went on to say the Administration welcomes calls or texts anytime. Council Member Rousselle told President Lepine that he asked for an update on the Ranatza Trailer gas line to be put on the agenda. President Lepine responded that he did not have an update. Council Member Rousselle ended the conversation by asking if we should assume, if there are no items under the President's Update, that Mr. Lepine will not give an update. WHEREAS, the U. S. Army Corps of Engineers has determined that certain lands situated in Plaquemines Parish are required to construct the New Orleans to Venice NOV-NF-W-05a.1, LaReusitte to Myrtle Grove project in Plaquemines Parish, Louisiana, hereinafter referred to as "the NOV-NF-W-05a.1 Project"; and

WHEREAS, the land estates required to construct the NOV-NF-W-05a.1 Project are identified in right-of-way drawings entitled "New Orleans to Venice, Louisiana, Hurricane Protection Project, NOV-NF-W-05a.1, First Lift Levee and Drainage Canal Relocation Project, LaReusitte to Myrtle Grove, Right-of-Way, Plaquemines Parish, Louisiana," File Number H-8-47489, Sheet Identification Numbers RE-01 through RE-22 (Drainage Canal Relocation), dated November 2018 and revised March 26, 2020 (Sheet R-04), and Sheet Identification Numbers RE-01 through RE-19 (First Lift Levee), dated November 2018, revised March 17, 2020 (Sheets R-03, 04, 14, 18, and 19 and March 26, 2020 (Sheet R-05) hereinafter referred to as "NOV-NF-W-05a.1 Right-of-Way Drawings" attached hereto and made part hereof as Exhibit A; and

WHEREAS, the "Perpetual Flood Protection Levee, Floodwall Easement" is a perpetual and assignable right and easement in the land described in Exhibit A, various tracts, to construct, maintain, repair, operate, Patrol, and replace a flood protection levee, floodwall, and gate closure, including all appurtenances thereto together with the right to trim, cut, fell and remove therefrom all trees, underbrush, obstructions and other vegetation, structures, or obstacles within the limits of the right of way; reserving, however, to the owners, their heirs and assigns, all such rights and privileges in the land as may be used without interfering with or abridging the rights and easement hereby acquired; subject, however, to existing easements for public roads and highways, public utilities, railroads and pipelines; and

WHEREAS, the constitution and laws of the State of Louisiana law provide that levee districts are authorized to appropriate and expropriate needed lands for levee, drainage, flood and hurricane protection purposes; and

WHEREAS, by letter dated December 6, 2018, addressed to Amos Cormier, as President of the Plaquemines Parish Government, the U. S. Army Corps of Engineers officially requested that Plaquemines Parish Government grant to the United States of America a clear and unobstructed right of entry, including the right of ingress and egress, to construct the aforementioned NOV-NF-W-05a.1 Project; and

WHEREAS, a copy of the aforementioned letter is attached hereto and made part hereof as Exhibit B; and

WHEREAS, by letter dated March 27, 2020, addressed to Kirk Lepine, as President of the Plaquemines Parish Government, the U.S. Army Corps of Engineers officially requested additional rights of way for a Perpetual Flood Protection Levee Floodwall Easement to maintain stability to the proposed levee in the areas of Midway Cattle Ranch, LLC and Woodland Borrow Pit, LLC as shown on the aforementioned NOV-NF-W-05a.1 Right-of-Way Drawings. In addition, the disposition item G-9, which was labeled as an eight inch retired pipeline has been changed to reflect a sixteen-inch Steel Oil Pipeline on the aforementioned NOV-NF-W-05a.1 Right-of-Way Drawings; and

WHEREAS, a copy of the aforementioned letter is attached hereto and made part hereof as Exhibit C; and

WHEREAS, in order to provide the U. S. Army Corps of Engineers the requested right of entry for the subject project, it is incumbent upon and the responsibility of the Plaquemines Parish Council, as and on behalf of the West Bank Levee District, to acquire by donation, purchase, appropriation and/or expropriation new Perpetual Flood Protection Levee, Floodwall Easements all in Plaquemines Parish as identified in the aforementioned NOV-NF-W-05a.1 Right-of-Way Drawings for levee, floodwall, drainage, flood and hurricane protection purposes;

NOW, THEREFORE:

BE IT ORDAINED BY PLAQUEMINES PARISH COUNCIL THAT:

SECTION 1

As and on behalf of the West Bank Levee District, that it finds that the acquisition by donation, purchase, appropriation and/or expropriation of new Perpetual Flood Protection Levee, Floodwall Easements all in Plaquemines Parish as identified in the NOV-NF-W-05a.1 Right-of-Way Drawings attached as Exhibit A are necessary, useful and required by the West Bank Levee District for drainage, levee, floodwall, flood and hurricane protection purposes and are required for the construction of the NOV-NF-W-05a.1 Project.

SECTION 2

As and on behalf of the West Bank Levee District, it does pursuant to the constitution and laws of the State of Louisiana hereby appropriate and authorize the acquisition of new Perpetual Flood Protection Levee, Floodwall Easements all in Plaquemines Parish to construct the NOV-NF-W-05a.1 Project for levee, floodwall, drainage, flood and hurricane protection purposes as identified in the NOV-NF-W-05a.1 Right-of-Way Drawings attached as Exhibit A.

SECTION 3

President Kirk Lepine is hereby authorized to approve, sign and issue the requested right of entry, including right of ingress and egress, to the United States of America for the construction of the aforementioned project.

SECTION 4

A copy of the NOV-NF-W-05a.1 Right-of-Way Drawings attached as Exhibit A shall be kept on file in the offices of Plaquemines Parish Government's Land Department.

SECTION 5

This Ordinance shall be published in the official journal of Plaquemines Parish Government in the manner prescribed by law and that a copy of this Ordinance shall be furnished to each known property owner affected thereby by certified mail, return receipt requested, in accordance with law.

SECTION 6

The compensation due the affected landowners as determined in accordance with applicable law shall be paid within one year of the date of the adoption of this Ordinance.

SECTION 7

The Secretary of this Council is hereby authorized to immediately certify and release this Ordinance and that Plaquemines Parish Government employees and officials are authorized to carry out the purposes of this Ordinance, both without further reading and approval by the Plaquemines Parish Council.

ORDINANCE NO. 20-58

The following Ordinance was offered by Council Member LaFrance who moved its adoption:

An Ordinance, pursuant to Act 665 of the 2016 Regular Session of the Louisiana Legislature relative to Communication Districts, to levy emergency telephone service charges (911 service charges); and otherwise to provide with respect thereto.

WHEREAS, the Plaquemines Parish Council at its meeting held on April 14, 1988, adopted Ordinance No. 88-121 creating, pursuant to the authority of Title 33, Chapter 31, Sections 9101-9106, of the Louisiana Revised Statutes, a communications district entitled, "Plaquemines Parish Communications District" ("District"); and

WHEREAS, on February 22 1990, the Plaquemines Parish Council acting as the governing authority of the District adopted Ordinance Number 90-24 calling an election for April 7, 1990, for the proposition of levying of a tariff rate for local telephone service supplied within each district, for the purpose of establishing, maintaining and operating the 911 Emergency Service Telephone System, provided that the service charge shall be imposed only upon the amount of the tariff rate for exchange access lines or their equivalent, of five (5%) percent of the tariff rate for local telephone service supplied within the district; and

WHEREAS, there is a need for the Pointe-a-la-Hache Ferry to run seven days a week from 6:00 a.m. to 8:00 p.m. not only to serve the residents on the east bank and the southern end of the west bank, but also due to the Courts, Clerk of Court, District Attorney, Assessor, Sheriff and Indigent Defender returning to their offices in the Pointe-a-la-Hache Courthouse;

NOW, THEREFORE:

BE IT ORDAINED BY THE PLAQUEMINES PARISH COUNCIL THAT:

SECTION 1

It hereby authorizes and directs the Parish President, or his designee, to have the Pointe-a-la-Hache Ferry run Monday through Sunday from 6:00 a.m. to 8:00 p.m.

SECTION 2

The Secretary of this Council is hereby authorized and directed to immediately certify and release this Ordinance and that Parish employees and officials are authorized to carry out the purposes of this Ordinance, both without further reading and approval by the Plaquemines Parish Council.

WHEREUPON, in open session the above Ordinance was read and considered section by section and as a whole.

Council Member Cognevich seconded the motion to adopt the Ordinance.

The foregoing Ordinance having been submitted to a vote, the vote resulted as follows:

Council Member LaFrance moved to Agenda Item 10, "New Business". Without objection, so ordered.

There were no items Agenda Item 10a, "Resolutions wherein suspension is being sought".

Under Agenda Item 10f, "District 1 update", Council Member Barthelemy said he was very disappointed with the last vote. Some members of the Council decided not to have the PALH ferry run from 6:00 a.m. to 8:00 p.m. Monday through Sunday. They are not supporting the people of the lower east bank and lower west bank. Other concerns are the Recreation program. The President will give an update on the Recreation program at the next Council Meeting. Council Member Barthelemy also said that the President was very responsive with his answers when calls were made to his office. He also said the Pointe-a-la-Hache Marina is in bad shape and the levees and Highway 15 south are in terrible condition. Council Member Barthelemy said we need to look into these issues.

Most everyone acknowledges that Black Lives Matter. It's a shame that when people say "All Lives Matter" it brings such derision, but likely that is because African Americans seek to bring attention to the fact that for some it appears Black lives do not matter given recent events.

Taking this perspective, one can understand their response to anyone who diminishes the message they seek to send. This is a way to make a firm statement that they are a part of this society and their lives do matter. It's not intended to be exclusive of others, merely to bring attention to their plight.

Anyone wishing to understand the origins of Black angst should take the time to read "Souls of Black Folk" by W.E.B. DuBois or "The Invisible Man" by Ralph Ellison. Both delve deeply into the sense of detachment felt by African Americans forced to live on the other side of the veil. The experience is scarring and unless you have lived it you cannot comprehend it.

Journalist John Howard

Griffin in the 1950s sought to learn for himself what Black life was like, so he darkened his skin and assumed the role of a homeless Black man traveling through the South. He called his memoir "Black Like Me." His is a telling story coming from someone who had never experienced discrimination to suddenly be confronted with its total impact during the height of Jim Crow.

Taking all this into consideration one can readily understand why the term "Black Lives Matter" had gained a foothold in the African American lexicon.

That being said, it seems that the term is limited in its application. No one condones the horrific abuses we have witnessed at the hands of a few police officers. However, one must ask do "All Black Lives Matter"?

What of the many thousands of young African Americans who have violently died in our cities? Young children shot while standing next to parents, participating in birthday parties, or even sleeping in their

own beds? Do these young lives matter?

What of the many young men and women who are murdered on city streets around America on a daily basis? How can it be that when protest attention is focused on the value of Black lives in the city, New Orleans experienced thirty shootings and about 5 deaths in four days this past week alone. One shooting even took place in the midst of the demonstration for Black Lives Matter. Shootings in the city are up 25%, homicides up 31%. Do these Black lives matter? Where is the outcry? Where is the protest?

Are we to look past these events like they never occurred? Are they Ellison invisible? Must we ignore the family losses? The scenes are witnessed all too often on the local news. The senseless loss expressed by crying parents, mourning friends, and distraught siblings resonate with anyone who has a heart. Outrage must be directed not only at the abuse of some police officers, but also at the daily carnage in the streets. We mourn for all the losses.

Black Lives do Matter, All Black Lives Matter! There is a crisis in our cities that demands attention. What has happened that so many believe they don't matter and act accordingly? That they are

expendable? That their lives lack meaning or value? How do we root out the prevailing anomie that has taken hold of so many of the young?

We need solutions. Demonstrations point out the need. Criminal riots and looting turn people away from the meaning of the movement. Politicians have all taken to hiding or, worse, seek political advantage. While some activists grab for selfish attention. As for the media, they only care about eye-catching headlines.

Many everyday Americans are fearful and confused today. Even the African American friends that I have had the honor to speak with express concern. They want change, but do not want to destroy our nation in the effort. They desire the unshackled freedom to take advantage of what America offers; they have no desire to stand on a bed of ashes as some Black businessmen must do today in Minneapolis.

All caring and thinking persons want a solution, but how does one achieve it with a total lack of leadership on all fronts? The American people of all ages, cultures, races, and religions feel abandoned. Cast adrift on a sea of turmoil, a ship tossed on waves of troubles with no captain or officers on watch.

Our nation and all its people deserve better!

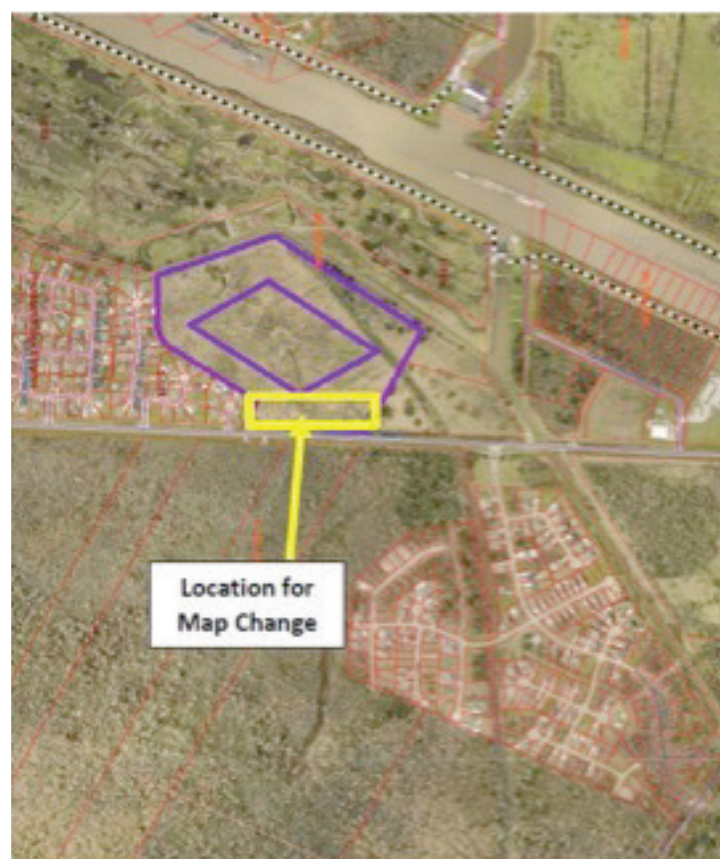

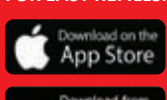
